This document is intended only as a roadmap for the proposed constitution change scheduled for special resolution at the November 2024 Extraordinary General Meeting.

It is not intended to be a complete and exhaustive treatise on the current to proposed constitution documents but as a general guide to the intent and implementation of the changes. Inaccuracies are assumed and members will need to examine the current and proposed constitutions themselves to have the best understanding of the proposed changes. The proposed constitution will also have a companion document - a Miranda Musical Theatre Company Playbook - that is being developed to deal with the operational issues that the Committee is required to handle. No part of the Playbook is able to contradict the overarching requirements of the proposed constitution.
